- (F Our target is to increase customer satisfaction and constantly promote the safety and environmental as well as health protection of our employees above and beyond the legal requirement.
- (B) The close co-operation of our R&D, production and sales departments guarantees first rate quality, product safety, compatibility with the environment and user friendliness, as well as the adherence to internal and external requirements.

- We are aware of the effects of climate change. Especially when developing new products, we take various sustainability aspects into account.

## Safety and Health:
